President Craft noted that a quorum of the Board was present, called the meetings to order at 3:05 p.m.

Ms. Miller stated that disclosures of potential conflicts of interest were filed with the Secretary of State for all directors prior to this meeting and no new conflicts of interest were disclosed at the meeting.

APPROVAL OF AGENDA:

After review of the Agenda Director Roberts moved that the Board approve the agenda as presented. Upon a second by Director Keeley a vote was taken, and the motion carried unanimously.

NEW BUSINESS:

2022 Rate & Fee Resolution: Mr. Schlegel presented a proposed 2022 Rate & Fee Resolution for the Directors consideration. Director Roberts moved that the Board open the Public Hearing. Upon a second by Director Keeley a vote was taken, and the motion carried unanimously, and the Public Hearing was opened at 3:06 p.m.

No Public Comment was received.

Director Roberts moved that the Public Hearing be closed. Upon a second by Director Keeley a vote was taken, and the motion carried unanimously, and the Public Hearing was closed at 3:07 p.m.

Mr. Schlegel described that all but one of the proposed increases are for fees that are billed to home builders at the time building permits are issued by Elbert County and are dictated by Resolutions previously adopted by the District's Board of Directors. The Water Meter and Equipment fee increase is necessary due to the increased costs of the equipment, of which the District does not mark up over what is charged by the manufacturer. Following discussion Director Roberts moved that the Board approve and adopt the 2022 Rate and Fee Resolution as presented. Upon a second by Director Keeley a vote was taken, and the motion carried unanimously.

Upon a second by Director Keeley, a vote was taken, and the motion carried unanimously.
